INVITATION to apply for United Nations Multidimensional **Integrated Missions' Orientation Course (UNMIMOC)** conducted on-line by Swedish Armed Forces International Centre (SWEDINT) and the Folke Bernadotte Academy (FBA).

1. Course purpose

While the UN integration agenda has been in place since the 1990s, several studies show that implementation is lagging. UN integration and its implications is often not well understood even by UN personnel serving in integrated missions, let alone adequately implemented on a day to day basis for it to have the promised impact of a more coherent delivery of UN support.

This training course aims to contribute to a better understanding among UN personnel on the purpose and practical implications of UN integration and enable them to develop the mindset required to effectively and successfully operate in an integrated UN mission context.

3. Target Audience

The UNMIMOC targets, firstly UN civilian, police and military personnel working in a peacekeeping mission, special political mission as well as UN personnel serving in agencies funds and programmes or secondly persons planned to deploy, within above mentioned organisations, in the near future. It is designed with participants in mind who may have had so far only limited exposure to integrated delivery of UN mandates but who are looking to improve their understanding of the UN's approach to integrated assessment and planning and increase their ability to work effectively and constructively with a wide range of UN actors on the ground.

4. Learning objectives

After a completed course the student will be able to:

- Understand the policy framework governing integrated missions.
- Distinguish the roles, responsibilities, and contributions of different UN actors in an integrated UN context.
- Understand the conditions that govern joint assessment, planning and mandate delivery within the UN system.
- Explain their individual contribution to a more effective coordination and collaboration in an integrated context.

5. Method

This course builds on many years of experience with previous in-class room training courses and joint exercises and considers the latest developments in policy and practice.

- 1. **Pre-course review** of material (read, watch & listen) providing a comprehensive overview of the policy frameworks governing integrated missions and the cooperation between missions and the wider UN system.
- 2. Exercises that give participants the opportunity to reflect and apply their knowledge of integrated assessment and planning in specific scenarios and contexts
- 3. **Briefings** and **discussions** with experienced practitioners and other participants on the "real life" challenges and opportunities in integrated contexts.

Pre-requisities

The digital course will span over a 5-day period from 6-12 Dec 2021. The methodology will be blended digital learning with participants using the morning hours to review material in advance, complete assignments and interact with other participants as required and interactive classes being held from 1200-1700 hrs Central European Time (CET) (timings subject to change).

8. Student assessment

The participants will be assessed based on activities during the course. Participants are required to take active part in syndicate seminar covering topics as briefed in lectures or in the pre-study tasks assigned during the course. Participants will then be assessed and graduated either with "Successfully completed" or "Participated". A course certificate will be presented at the end of the course. Take active part means asking questions, presenting a stand point in debates and showing a willingness to explain it to fellow students and instructors.

9. Language proficiency

Students must be in command of English as described in NATO standardization agreement (STANAG) 6001¹:

Listening Good (3), Speaking Fair (2), Reading Good (3), Writing Fair (2).

Language testing is a national responsibility. No additional training or translation will be provided.

10. Computer skills

Participants need basic computer skills to ensure their successful participation in the course. The learning platform to be used will be Zoom, with pre-reading material and other information being posted on a "Swedish Defense Forces Database portal" (webb based). This will include PDF copies of delivered PowerPoint lectures, student evaluations and a feedback survey etc.

SWEDINT will provide further information and training for all students in respect of the chosen IT Platform in due course.

12. Swedint policy on personal data

In order to get a seat on a course at **SWEDINT** the applicant will be asked to provide personal data. a. Student Application

Student applications should be sent to **SWEDINT** NLT 7th Nov 2021 The application form with CV / registration form will be found at: www.mil.se. The application form, authorized and signed by the national authority/POC, has to be sent together with the CV to **SWEDINT** via e-mail, mail or fax.

Nominations received later will only be considered, if space is available.

b. Important information to national administrators etc:

It is important that this invitation reaches the applicant intended to apply for a seat on the course since it contains information that he/she needs in the application process.

c. Internet access before the course

Prior to joining the course at **SWEDINT** students will need access to internet in order to retrieve information that **SWEDINT** provides on the web page before the online course starts, such as course curriculum, application form etc. For access to course documents and reference material once admitted to the course, an online educational platform will be used.

The online educational platform used to provide course documents, reference material and other important information to the students is called *itslearning*. Sessions in virtual classrooms will be conducted through *Zoom*.

SWEDINT will arrange accounts for each course participants admitted to the course.
